WHEREAS, the recognition was granted to the institution namely, Central Sanskrit University Guruvayoor Campus Puranattukara, thrissur Dist, Kerala-680551 vide SRC (NCTE) order No. F.KL/SRO/NCTE/2005-2006/2333 dated 09.08.2005 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2005-2006.

- AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by consented to come under new Regulations vide a notarized affidavit dated 19.01.2015.
- AND WHEREAS, a Revised Provisional Recognition Order (RPRO) was issued to the institution on 15.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 50 students (one basic units) from the academic session 2015-2016.
- AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 381th meeting held on 31th October & 1th November, 2020 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance.
- AND WHEREAS, Accordingly, Show Cause Notice issued on 15.09.2020 to reply within 21 days. The institution vide letter dated 04.11.2020 submitted reply to Show Cause Notice.
- AND WHEREAS, the matter was further considered by the SRC in its 392" meeting heid on 15th - 16th December, 2020 and the Committee decided as follows:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993. Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made -

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution Central Sanskrit University Guruvayoor Campus Puranattukara, Thrissur Dist, Kerala-680551 for B.Ed programme for 1 basic unit of 50 students."

- NOW THEREFORE, this order is issued permitting the institution Central Sanskrit University Guruvayoor Campus Puranattukara, Survey No. 61 Dist, Kerala-680551 for B.Ed. course of two years duration with an annual intake of 50 students (one basic units) subject to fulfillment of the following conditions:
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with 1. Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - The institution shall comply with the various other norms and standards prescribed in the NCTE 11. Regulations, 2014 as amended from time to time.



Preamble:

The Rastriya Sanskrit Sansthan Deemed University, Guruvayur Campus, Thrissur, Kerala has been granted recognition with an intake of 100 students for B.Ed course.

The Government of India in Central Educational institution (Reservation in Admission) Act, 2007, has made separate quota for OBCs. The Central Government has decided to enhance the intake of Government institutions for providing reservations under the said Act to the OBCs.

The Rastriya Sanskrit Sansthan Deemed University, Guruvayur Campus, Thrissur, Kerala has made application on 25.09.2008 requesting for increase of intake of 27 students in view of the above Act.
